Dear Customer,

This year marks twenty four years since the District was formed. The MUD's priority continues to be ensuring that all of our customers have reliable water and sewer services.

Aqua Water Supply Corporation, supplier of our drinking water, has recently raised the water rates it charges the District for water.

The Board spent several months reviewing the cost implication from the new Aqua WSC water rates. They also took into consideration the impact of inflation over the past year, including the District's suppliers and contractors. For these reasons, the Board approved an increase in water rates that become **effective June 1, 2023**.

**This is the first rate increase in eleven years.** Even with the increases, BC MUD No.1's rates remain very much in line with other water providers in the Bastrop County area (see attached new rates).
